The external supervisor is aware of the departmental colloquium where the results will be presented and discussed. With the signature the external supervisor agrees to the above-mentioned regulations.*

## Application



Complete the form, add an updated ZEuS print and submit to the departmental office.
- The administration checks if all requirements are fulfilled.
- Agree appointments for the oral exam and inform the departmental office.
- **After** the oral exam:  
Complete the form "Application for admission to the Master's Thesis Life Science", have it signed by the official supervisor and submit to the departmental office.

## Deadline extension

- To extend the deadline please apply for it in written form and submit it to the examination board. The application must mention the original deadline, the new deadline and the reason for the extension. Sign this application.
- Have the application signed by your supervisor
- Submit the application for the deadline extension to the departmental office.

## Submission

- Following documents must be submitted:
  - three bound copies (no ring binding) of your master's thesis
  - declaration of independent work in German as an **extra sheet**
  - in addition the declaration (in German) **must** be bound in the master's thesis
  - certificate of enrollment of the running and last semester
  - in case the title of the thesis was changed, please submit the corresponding form and have it signed by your supervisor.
- Submission of your master's thesis including all documents at the departmental office (L801).
